Theatre Hullabaloo believes that creativity should be part of everyone's childhood. We are a pioneering organisation that makes, tours and promotes theatre for children and young people because we believe that they are the most important audience of all. Established as Cleveland Independent Theatre Company, a general regional touring theatre company in 1979, the organisation became a specialist young people's company in 1994 (CTC Theatre) and was then reimagined as Theatre Hullabaloo in 2009.

Theatre Hullabaloo is a National Portfolio Organisation (NPO) of Arts Council England, a registered charity and one of the leading specialist children's theatre organisations in the UK. We make and commission new work for audiences from birth to 16 years which tours regionally, nationally and internationally to a mixture of theatres, venues, schools, nurseries and community settings. We also deliver a busy artist and sector development programme, believing that our audiences deserve work made by the most brilliant of artists and we work with a range of partners and stakeholders to produce research into the value of creativity in the lives of children which impacts on national policy in this area.

In December 2017, Theatre Hullabaloo realised the dream of opening a purpose-built venue for children and families in Darlington. The Hullabaloo presents a year-round programme of world-class performances, free creative play installations, family-focussed activities, and participatory work with particular emphasis on early years creativity.

The venue has already welcomed over 80,000 children and their grown-ups through its doors to see wonderful theatre specially made for them, engage them in magical play installations and much more. The venue was named 'Best Family Venue 2019' in the national Fantastic for Families awards.

BACKGROUND

Theatre Hullabaloo is an arts charity committed to ensuring that creativity is part of everybody's childhood. Based in Darlington at The Hullabaloo, a purpose-designed theatre for children, we produce, programme and present world-class performance, creative play installations and events targeted specifically at young audiences and their families. We have a particular specialism in creativity in early years.

Over the next financial year Theatre Hullabaloo is anticipating income growth from £394k to £1.4 million, following successful bidding on a number of projects. Included in our Board approved budget we have a number of projects such as: Hullabaloo Programme, Hullabaloo in the Park, Artist Development, New Show Development, Practise & Influence, Creative Play installations, Creative Play museums, Place to Play, TVCEP project management and TVFN Network Management.

The staffing structure in the organisation has also changed significantly over the last year to support the growth of the new structure. Theatre Hullabaloo's staff team has also grown from 8 core team members and 4 hosts in 2022-23 to a staff team of 14 core team members and 11 hosts in 2024-2025. We also contract a number of temporary and freelance staff members throughout the year, expected to be around 100 in 2024-2025.

Theatre Hullabaloo is a company registered in England and a UK registered charity and is governed by a Board of Trustees. Board meetings are held quarterly involving Trustees and the Senior Management team. Management accounts are produced every quarter and presented to a Finance Sub-group which oversees all financial activities, before presentation to the full Board.

Our current Board members are: Anne Besford Chair - Chief Executive National Youth Choirs of Great Britain, Simon James Vice Chair - Professor of English, Durham University & Lead for Durham Commission on Creativity & Education, Michael Costelloe Access & Inclusion Champion - Solicitor, EMG Solicitors Ltd, Terry Courtney Chair of the Finance Subgroup - Retired Finance Director, Kerami Roberts Access & Inclusion Champion - Disability and Access Advocate & Qualified Music Teacher and Supriya Nagarajan Access & Inclusion Champion - Artistic Director of Manasamitra, a UK based arts charity.

KEY FINANCIAL RESPONSIBILITIES WITHIN THE ORGANISATION:

Chief Executive Officer:

- Prepare and report on annual budgets for the organisation and its programme of work with support from the General Manager and Artistic Producer.
- Writing, developing, leading and reporting on the income generation strategy.
- Cultivating new revenue funding relationships with corporate partners, donors and trusts and foundations.
- Development of new funding relationships and maximising and diversifying commercial income streams.
- Monitoring and reporting against financial risk and return on investment to the Board on a regular basis.

General Manager:

- Maintain financial and management accounting systems, banking, and payroll with assistance from external accountants and the Finance and Administration Officer.
- In conjunction with the CEO and Artistic Producer, prepare annual budgets for monitoring and approval by Trustees.
- Have oversight of delegated budgets across the organisation, supporting the team to manage these, and provide regular monthly reporting to the Senior Management Team.
- Monitor and report against sales targets
- Prepare and sign off monthly payroll and make pensions returns.
- Play a key role in the annual audit and associated statutory returns.
- Manage and support staff, including the Finance and Administration Assistant and other members of the staff team as allocated by the CEO.

Finance and Administration Officer:

- Carry out all day-to-day finance procedures; input financial transactions into Sage, chase payments and raise invoices, paying invoices, reconcile petty cash, process expenses claims, monitor cash donations, perform bank reconciliations and any other bookkeeping as required.
- Liaise with accountants regarding payroll, gift aid and tax queries
- Alongside the General manager manage payroll / pensions submissions and administration of new starters
- Supply information to the Pensions Regulator as required
- Support the General Manager, accountants and audit process as required
- Drafting and posting of journals onto Sage
- Performing daily checks on transactions submitted by the core team, including checking coding against budgets in collaboration with the General Manager.
